The District is organized under the laws of the State of Illinois for the purpose of providing the residents with schools for grades **pre-K through 8** for the education of all eligible persons in the District.

The District operates the following schools (all located in Lockport, Illinois):

Milne Grove School, for grades pre-K – 3, located at 565 East 7th Street.

Kelvin Grove School, for grades 4-8, located at 808 Adams Street.

The **Administrative Office** for the District is located at Kelvin Grove School.

The District is governed by a seven-member Board of Education. The **office of the Board of Education** is located in Kelvin Grove School, 808 Adams Street, Lockport, Illinois 60441.

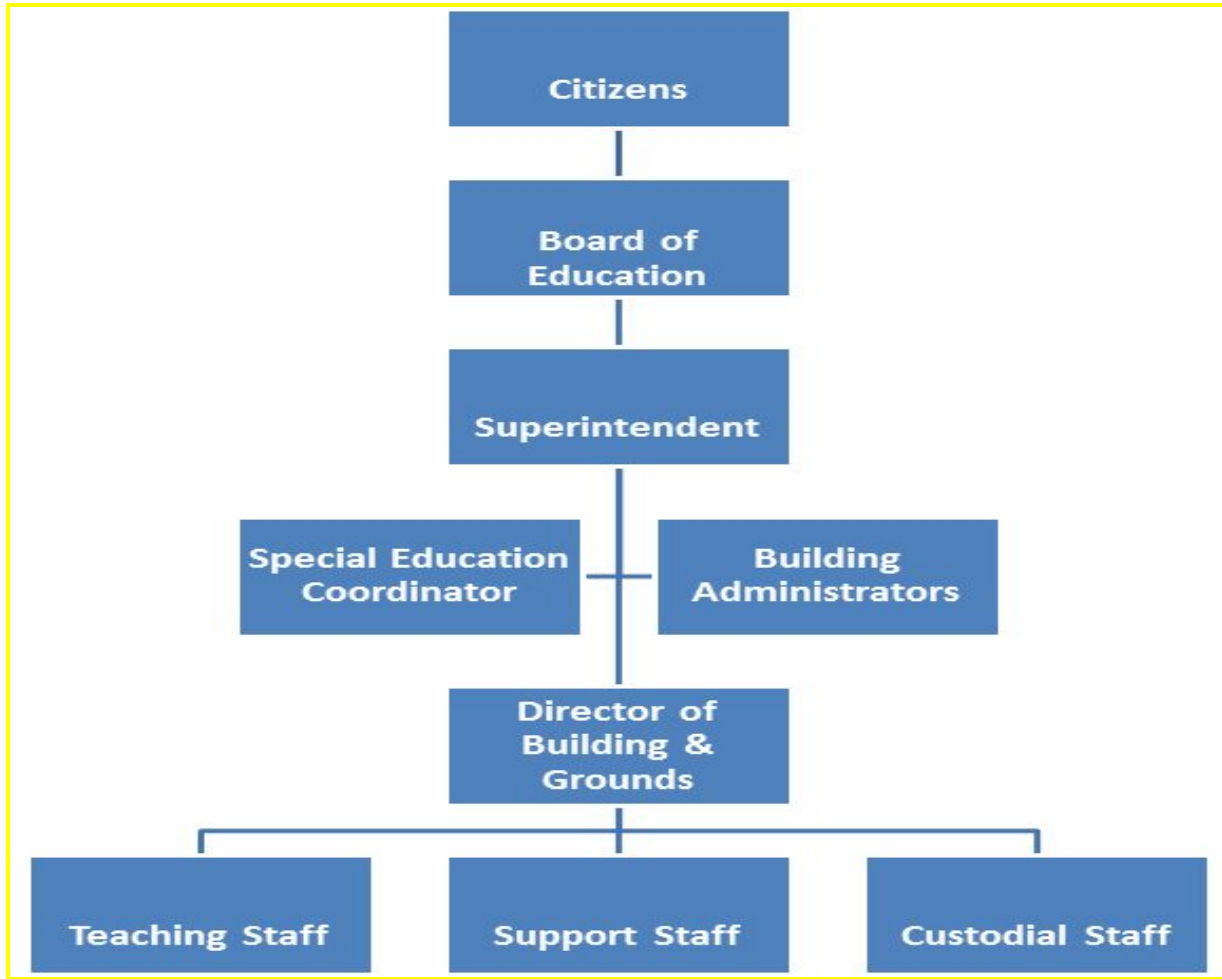

\$1.00 per page to certify.
